Re: OIA request - transfers of mothers and newborn babies between DHBs

Thank you for your Official Information Act request received 2 July 2019 seeking the following of Waitematā District Health Board (DHB):

"How often have expectant mothers and/or newborn babies been transferred from Waitematā DHB to DHBs outside the Auckland area in the past three years?

Why were they transferred? (e.g. because neonatal ward was at capacity, or because DHB does not ordinarily have the facilities needed in a particular case)

Where were they transferred to?

Were any transferred to Australia?

Can you please tell me the occupancy rates for your neonatal wards over the past three years?"

## **Transfers**

Waitematā DHB provides maternity and neonatal services at both Waitakere and North Shore hospitals. In a typical 12-month period, our services are involved in the birth of approximately 7,000 babies.

A review of discharge data between 30 June 2016 and 30 June 2019 shows that there were no expectant mothers transferred from Waitematā DHB to other DHBs outside the Auckland area.

Within the same time period, there were nine babies transferred from Waitematā DHB to outside metropolitan Auckland. In each case, the babies' mothers lived in the Northland DHB area and had given birth at Waitematā DHB.

All nine babies were relocated to the care of their DHB-of-domicile when it was clinically safe for them to be transferred home.

Waitematā DHB has not transferred any mothers or newborn babies to Australia in the last three years.

## Occupancy

Waitematā DHB has two 12-cot neonatal units, one at North Shore Hospital and one at Waitakere Hospital. The table below outlines average monthly occupancy rates (at midnight) by unit from 1 June 2016 to 31 May 2019.
