Re: OIA request - Heart-related hospital admissions

Thank you for your Official Information Act request received 24 May via transfer from the Ministry of Health seeking information from Waitematā District Health Board (DHB) about heart-related hospital admissions.

Before responding to your specific questions, it may be useful to provide some context about our services.

Waitematā is the largest and one of the most rapidly growing DHBs in the country, serving a population of around 650,000 across the North Shore, Waitakere and Rodney areas. We are the largest employer in the district, employing more than 8,900 people across more than 80 locations.

In addition to providing care to our own resident population, we are the Northern Region provider of forensic mental health services and child rehabilitation services, plus the metro Auckland provider of child community dental services and community alcohol and drug services.

In response to your request, we are able to provide the following information:

2. All acute myocarditis, pericarditis and tachycardia admissions post-COVID-19 diagnosis

Please note that where numbers are fewer than five, we are withholding the exact number under section 9(2)(a) of the Official Information Act to protect the privacy of the individuals involved.

We have considered whether the public interest in releasing this information outweighs the need for individual privacy and have concluded that it does not. The general expectation that medical records will be kept confidential means that patients are entitled to rely on the DHB not to create the risk that they will be identified.

You have the right to seek an investigation and review by the Ombudsman of this decision. Information about how to seek a review is available at www.ombudsman.parliament.nz or freephone 0800 802 602.

Y479 - Sedative, hypnotic and antianxiety drug, unspecified causing adverse effects in therapeutic use
