## Re: OIA request - Children's health conditions

Thank you for your Official Information Act request received 30 March seeking information from Waitematā District Health Board (DHB) about children's health conditions.

Before responding to your specific questions, it may be useful to provide some context about our services.

Waitematā is the largest and one of the most rapidly growing DHBs in the country, serving a population of around 650,000 across the North Shore, Waitakere and Rodney areas. We are the largest employer in the district, employing around 8,600 people across more than 80 locations.

In addition to providing care to our own resident population, we are the Northern Region provider of forensic mental health services and child rehabilitation services, plus the metro Auckland provider of child community dental services and community alcohol and drug services.

In response to your request, we are able to provide the following information:

Can I please have the number of children (aged 0-14) recorded by your DHB with the following conditions in the years 2014, 2017 and 2020?

- whooping cough
- rheumatic fever
- bronchiolitis
- broncho pneumonia
- serious dental disease
- malnutrition.

<sup>\*</sup>Community treatment of whooping cough is managed in primary health care. To provide a response to this aspect of your request would require the review of a large volume of individual clinical records of patients held by the GP practices in our catchment.

Due to the sensitivity of this information, our frontline clinical staff would need to collate the information. This would take our staff away from their core functions and prejudice our ability to provide core services.

We have considered whether charging or extending the timeframe for responding to this aspect of your request would assist us in managing this work and have concluded it would not. We have, therefore, determined to refuse this element of your request under Section 18(f) of the Official Information Act due to substantial collation and research.
