Re: Official Information Act request - school dental statistics

Thank you for your Official Information Act request transferred from Auckland District Health Board (DHB) on 3 May and your additional request received 9 May. You have sought the following of Waitematā DHB for the 2014 year only:

5yr olds, Y8, Maori/Pacific/other, fluoridated/not/ male/female if available, by dmft/DMFT score, for the 3 Auckland DHBs.

This information is provided to you in the spreadsheet attached.

You also asked:

There is some further info I need, but you might not be the right person to ask. I need to control as much as possible for socioeconomic status. We have the Deprivation data by meshblock/CAU thanks to Otago Uni. I need to match these to the fluoridated and unfluoridated areas. I know Onehunga and Huia are not fluoridated, plus the rural areas of counties manukau. There is a CAU called Onehunga – does that match the F/non-F boundary?

There is no CAU called Huia, but Huia seems to be in Takanini South CAU. Again, is that then boundary?

What CAUs are F/Non-F in Counties manukau?

If this info isn't available in this form, can you provide a geographical map with the boundaries on it -1 can then transfer this to the meshblock map from the Deprivation files.

Other than that, are the boundaries of the fluoridated supplies the boundaries of the three areas?

In response, I can advise that Waitematā DHB does not hold specific information that can assist you with this query. However, the links below may assist, they will direct you to maps of fluoridated /non-fluoridated areas, DHB boundaries (third link) and census unit area interactive maps (fourth link).
